New map of Portland area reveals Missoula floods features

Portland, Oregon: The Oregon Department of Geology and Mineral Industries (DOGAMI) has released a lidar-based map showing Missoula floods inundation and features in the Portland metropolitan area.

"Lidar-derived imagery allows us to map the shape of the surface of the earth in resolution never before seen, especially in places that are densely vegetated, such as the Portland Basin," says Bill Burns, DOGAMI Engineering Geologist. "With this map we can see major flow paths of the floodwaters, scour areas, and bars and deltas. The land surface of the entire Portland area was dramatically altered by this catastrophic flooding."

The map also depicts 3-D views of Oswego Lake, Canby, and Battle Ground, Washington, where flood features are particularly spectacular.
