

Additional lidar data available for Klamath County

Portland, Oregon: The Oregon Department of Geology and Mineral Industries (DOGAMI) has released additional lidar data for the Klamath County, Oregon area. The new data extent covers approximately six USGS topographic quadrangles in the vicinity of John Boyle Reservoir, Surveyor Mountain, and Mule Hill. Lidar, a laser-mapping technology, allows for amazingly detailed and accurate mapping of the earth's surface.




DOGAMI Lidar Data Quadrangle (LDQ) Series coverage as of 03/2013
